Historical Note:

The earliest form of the Nashville Police Department was initially established in 1806, when the Tennessee legislature enacted a law incorporating the Town of Nashville, with John Deatheridge as High Constable. In 1850, the High Constable was replaced by the City Marshal, and eventually the Chief of Police replaced the City Marshal. Beginning with a watchman system, Nashville's police later transitioned to a metropolitan police force after the Civil War.

After the city-county consolidation in 1963, Nashville's police became the Metropolitan Nashville Police Department, with Hubert O. Kemp serving as the first Metro Police Chief from 1963-1972. Currently, the MNPD provides law enforcement services over a 526.1 square mile area, encompassing both high-density urban locations and rural areas of Nashville and Davidson County.

Scope and Contents of the Collection:

The Metropolitan Nashville Police Department records contain the predominantly administrative records for the department. This collection includes reports, payroll books, arrest blotters and cards, and correspondence documenting the day-to-day activities and history of Nashville's police from 1870 until 2004. Most records date between 1930 and 1970, and some records chiefly those pertaining to juveniles - are closed to research.

Arrangement:

This collection is arranged alphabetically into five series: Administrative Records, Correspondence, Images, Ladies Auxiliary, and Reports.

The *Administrative Records* series contains materials relating to the day-to-day activities of the Nashville Police Department. A large portion of this series includes arrest blotters dating from 1870 to 1938, and arrest cards for individuals dating between 1935 and 1945. This series also includes time books and payroll books for department staff, the MNPD manual, and operating policies and procedures. Other items of note include a list of African-American police officers from 1966, and a list of officers killed in the line of duty between 1885 and 2004.

The *Correspondence* series largely contains letters written to and from the Chief of Detectives between 1949 and 1954. Most of this correspondence relates either to missing or wanted people, or lost or stolen property.

The *Images* series includes historical photographs and negatives taken by the Nashville Police Department. Most images are undated, and approximately 145 negatives have been digitized by Metro Archives.

The *Ladies Auxiliary* series contains correspondence, financial reports, and meeting minutes for an organization formed by the wives and mothers of Nashville police officers. Dates range from 1929-1957.

The *Reports* series includes a large run of annual reports of the Police Department from 1874 to 1939, with some gaps. Also included are reports relating to program studies, improvement plans, departmental award recommendations, and the design of the Criminal Justice Center.
