### Biographical Note:

Dr. Kate Savage Zerfoss and her husband, Dr. T.B. Zerfoss, were Nashville doctors with deep ties to the Vanderbilt University Medical School and student community. Kate Savage Zerfoss' relationship to Vanderbilt actually began with her father, Dr. G.C. Savage, who was Chair of Ophthalmology and Otology at Vanderbilt University Medical School from 1886 to before his death in 1930. Dr. Kate Savage Zerfoss and her husband, Dr. Tom, founded the Student Health Center at Vanderbilt University in 1926 and spent over 30 years serving Vanderbilt students.
